DRR - CUSTOMER SAFETY INFORMATION AND WARRANTY REGISTRATION FORM

Every effort has been made to design and construct a safe product, and your Dealer has assembled and inspected it and believes it to be a safe product. There is, however, always the possibility of severe injury, death and/or property damage that can result from improper or careless operation. This product is not a toy and may be hazardous to operate.

In order to induce the undersigned Dealer to deliver a DRR Inc., 4-Wheeler, off-road vehicle (hereinafter called Vehicle) to the below signed purchaser, Purchaser agrees and promises to hold DRR Inc. (hereinafter called DRR) and the Dealer harmless and indemnify them from all claims and demands or causes of action which may arise or be asserted against them arising or allegedly arising from any claim related to the delivery of the Vehicle or its use by the Purchaser or any third parties, including all attorney fees and legal costs whether or not any claim or assertion is deemed or found to be valid or not. All parties agree and stipulate that any legal proceedings which relate to or arise out of this transaction shall be brought only in a federal or state court located in the County of Medina, State of Ohio.

This form contains vital safety information. Your dealer will review the warnings with you and ask you to verify that you have read and understood each warning by placing your initials on the line beside it.

Failure to obey these warnings could result in death or severe personal injury.

I understand that I must:

- 1. Always read the owners manual carefully and follow the operating procedures described and follow all instructions and warnings contained in the manual and on all labels. Never operate an ATV without proper instruction. Take a training course. Beginners should receive training from a certified instructor. Contact DRR at (330) 220-3102.
2. Never allow children under 6 years old to operate the vehicle. Never allow children under 12 years to operate the Vehicle if the engine is 70cc or over. Never allow children under 16 years old to operate the Vehicle if the engine is 90cc or over without adult supervision in addition to proper training and instruction.
3. I attest that the child for whom this Vehicle is purchased is of proper age.
4. Never allow any operation of the Vehicle before reading the owners manual and viewing the 4-Wheeler video.
5. Never allow the Vehicle to be driven on a public road of any kind, even a dirt or gravel road, because the driver may not be able to avoid colliding with other vehicles. Also, operating on a public road may be against the law.
6. Never let a child ride the Vehicle without close adult supervision. Not all children have the strength, size, skill or judgment needed to operate the Vehicle safely.
7. Never allow more than one person to ride on the vehicle. A passenger may affect the balance and steering of the Vehicle and increase the risk of losing control.
8. Never allow an adult to supervise a child operator after the adult has consumed alcohol or drugs.
9. Never allow a child to operate the Vehicle unless the child is wearing approved protective gear including helmet, eye protection, chest protection, protective clothing and off-road, non-lace style boots.
10. Never allow a child to operate the Vehicle on unsafe terrain or at speeds too fast for their skills or the conditions.
11. Always use proper riding techniques to avoid Vehicle turn-overs on hills and rough terrain.
12. Never operate the Vehicle on pavement. It is not designed to be used on paved surfaces and may seriously affect handling and control.
13. Never alter Vehicle in anyway which may alter performance, speed, electrical components, and or any changes to OEM specifications.
14. Never allow a child to do wheelies, jumps or other stunts.
15. Racing, or alteration in anyway from original, voids warranties.
16. A copy of this registration, with original receipt must be delivered to DRR within 7 days of purchase or failure to do so voids all warranties.
17. The purchaser acknowledges and agrees that he has watched the safety/training video, will follow all steps outlined in the video, and that failure to do so voids all warranties.
